THE FORUM'S FLAGSHIP ACTIVITY IN 2023 WAS THE 6TH MICRONUTRIENT FORUM GLOBAL CONFERENCE HELD ONLINE AND IN THE HAGUE, THE NETHERLANDS FROM OCTOBER 16-20. OVER 2,200 EXPERTS, SCIENTISTS, PRACTITIONERS, AND PUBLIC OFFICIALS FROM AROUND THE WORLD AND ACROSS DISCIPLINES CAME TOGETHER TO EXPLORE THE INTERDEPENDENCE OF MICRONUTRIENT NUTRITION AND THE RESILIENCE OF INDIVIDUALS, COMMUNITIES, AND SYSTEMS, IN THE CONTEXT OF A WORLD WHERE GLOBAL CRISES ARE THE NEW NORMAL. MORE SPECIFICALLY, THE CONFERENCE AIMED TO:

- BETTER UNDERSTAND THE ROLE OF MICRONUTRIENTS IN IMPROVING RESILIENCE AND CONSIDER POTENTIAL APPROACHES TO EXPLOITING THIS ROLE SO THAT INDIVIDUALS, HOUSEHOLDS, AND COMMUNITIES CAN ACHIEVE GREATER RESILIENCE IN A WORLD OF SHOCKS.

THE MICRONUTRIENT DATA INNOVATION ALLIANCE (DINA) HAS MADE SIGNIFICANT PROGRESS IN 2023, ESPECIALLY IN PROVIDING SUPPORT TO NATIONAL ACTORS.

DINA PROVIDED GRANTS TO TEAMS IN COLOMBIA, ETHIOPIA, INDIA, MALAWI AND SIERRA LEONE, EACH ADDRESSING A CRITICAL ASPECT ALONG THE MICRONUTRIENT DATA VALUE CHAIN. ALSO, DINA AND THE LEARNING NETWORK ON NUTRITION SURVEILLANCE (LENNS) AGREED TO COLLABORATE TO CO-ORGANIZE AN AFRICAN REGIONAL MEETING ON ISSUES AROUND ANEMIA DATA. THE PREPARATIONS FOR THIS MEETING STARTED IN OCTOBER 2023, WHEREAS THE MEETING ITSELF TOOK PLACE END OF JULY 2024 IN NAIROBI.
